PRIVACY POLICY

textile.training (Dot Training Group Pty Ltd) – Your Privacy is Our Business

Your right to privacy is a responsibility we take very seriously and we handle your personal information with complete care.

Our Privacy Policy goes into detail about how we collect and handle your personal information, as well as who we exchange your information with, how we store your information and how you can access and correct your information – plus how you can make a complaint about any perceived breach.

This Privacy Policy applies to the services offered by textile.training (Dot Training Group Pty Ltd) (ABN 43 614 519 872).

Statement Of Confinement:

textile.training is committed to protecting your privacy and that includes any personal information about you that we collect. textile.training complies with the Privacy Act 1988 (Cth). This policy explains how we may collect, use, disclose and otherwise handle personal and sensitive information.

textile.training is committed to safeguarding your personal privacy. We recognise that all individuals have a right to control how their personal information is collected - and used – and we take that seriously. Providing personal information is an act of trust and we appreciate your trust in us – we'll do our best to never let you down. Unless given consent to do otherwise, textile.training will only collect and use personal information as set out below.

For the purposes of this Privacy Policy, your personal information may mean some or all of the following: a member's name, contact details, date of birth, emergency contact details, bank account and/or credit card details, student identification details, employment details, payment history and related sensitive information.

Collecting Personal Information:

textile.training will not collect or monitor any personal information about an individual without their personal consent. The only personal information that we collect when you sign on with textile.training is what is provided voluntarily – when you join as a member or enquire as a prospective member.

The reason we collect your personal information, primarily, is to enable us to provide members with our services. textile.training may also use the information for marketing to you, or for any other purpose permitted under the Privacy Act 1988 (Cth).

You don't need to identify yourself when you deal with us (e.g. to find out more about membership packages), however, in some situations, our textile training team will only deal with individuals who have identified themselves to us.

When a training service or product is purchased from textile training personal information will be requested in order to provide the requested service or product, provide updated information, and advise of other textile training products, which may be of interest to your training journey. You are not under any obligation to provide

this personal information, however, your failure to do so may result in textile.training being unable to provide services or products to you.

Personal information is collected directly from members or potential future members when they personally complete and submit an application form to become a member of textile.training. This can be done in person with one of our textile.training team.

For the purposes of this Privacy Policy, sensitive information means the information a member has disclosed to us about their physical and mental health and well-being.

Collecting Sensitive Information:

Sensitive information will only ever be used for providing services to members. Your personal information will not be used or disclosed for any other purposes without your consent, except in exceptional cases when disclosure may be required by law or is necessary to protect the rights or property of textile.training, any textile.training group company, or any member of the public, or to lessen a serious threat to a person's health or safety. For the purposes of this Privacy Policy, sensitive information is a subset of personal information.

Using And Disclosing Your Personal Information:

Personal Information will be used for the following primary purpose:

- - To fulfil obligations under a member's membership agreement and/or any other contract between him/her and textile.training;
- - To render services under a member's membership agreement;
- - To provide information about products, service and/or special offers to members;
- - To obtain opinions or comments about products and/or services from members;
- - To record statistical data for marketing analysis from members.

textile.training may employ other companies or service providers to assist us in providing our services, including (but not limited to) marketing, market research, mail-house services, hosting and product development services, analysis of member lists and/ or consulting services. These third parties may have access to personal information that is needed to perform their specific function. They cannot use that information for other purposes.

textile.training recognise the trust you have in us when you provide personal information, and such information will not be used or disclosed for any other purposes without consent, except in exceptional cases when disclosure may be required by law or is necessary to protect the rights or property of textile.training, any textile.training group company, or any member of the public, or to lessen a serious threat to a person's health or safety.

Contact By textile.training:

textile.training does not send advertising information without obtaining prior consent. If an individual receives communications from textile.training, which they do not

wish to receive, they may remove their name from the database by contacting textile.training directly.

Use Of Tracking Technologies:

textile.training uses tracking technologies, such as cookies or web beacons, to make use of its website and services as convenient as possible. Cookies are pieces of information that a web site transfers to a computer's hard disk for the purposes of record-keeping. Web Beacon is a technical method that sends information related to the access to websites, when you browse websites, open or preview an HTML-formatted email. Most web browsers are set to accept tracking technologies, such as cookies or web beacons. These tracking technologies do not personally identify users, although they do identify a user's browser. These tracking technologies allow textile.training to monitor the textile.training web site, and to record how many people are using the different parts of the site. It is possible to set the browser to refuse tracking technologies, such as cookies or web beacons, however, this may limit the services provided by textile.training's web site.

Individual's Right Of Access:

Individuals have the right to review, amend or delete personal and/or sensitive Information that may be recorded on the textile.training database. Information may be reviewed, amended or deleted by talking to our textile.training team directly on (03) 8680 2517.

A request may be made to delete personal and/or sensitive information, and all reasonable steps to delete the information will be made, except where it is required for legal reasons. Deletion of information may result in textile.training being unable to sell products directly and/or provide certain services including after sales services.

Storage And Security Of Personal And/Or Sensitive Information:

At textile.training, we take all reasonable steps to keep secure personal information recorded and to keep this information accurate and up-to-date. textile.training only permits authorised personnel to access your information and information will only be disclosed to third parties where they have the appropriate authority.

Textile.training And Links To Other Web Sites:

When textile.training provides links to web sites outside of the textile.training site, it is important to remember that these linked sites are not under the control of textile.training, and textile.training is not responsible for the conduct of companies linked to the textile.training web site, nor for the performance or otherwise of any content and/or software contained in such external websites.
